

## **Privacy Policy**

Thank you for visiting our corporate website at [www.sanyospecialsteel.in](http://www.sanyospecialsteel.in) ("We"/"SSMI" refers to Sanyo Special Steel Manufacturing Private Limited, (also referred to as "us", or "our") (SSMI. (This Privacy Policy shall be referred and read as an integral part of the Terms of Use of the SSMI Website.)

Your privacy is important to us, and this Policy will explain how we collect and use information that personally identifies you ("personal information") as well as non-personal information about your interaction with the SSMI Website.
